



# The Ultimate Musician Kids Class

## Terms & Agreement

### Registration

Class registration for the fall semester of The Ultimate Musician Kids Class, which is an after-school music program, must be completed by the 25th of the month to cover upcoming classes. Tuition will be due on a bi-weekly or monthly basis. A registration link is on the event page of the website [here](#). By registering, you are providing Skyler's Music Studio, LLC with contact information for notification purposes, as well as confirming the child's slot in the class. Once the initial registration is complete, an email will be sent enclosing this agreement for an electronic signature and further information.

### Class

Skyler's Music Studio, LLC will provide children ages 5 through 9 with a small group musical experience through this weekly class. Music theory is integrated into each lesson through the Music Theory Coloring & Activity Book, where each student will have their own copy. Students will have their very own set of popular percussion instruments, including the glockenspiel, which will be a focus in the class. In-class instruments will be available, including a keyboard, which will be used to teach mini piano lessons. Alfred's method will be used for this segment of the class. Classes are rooted in song, so students will learn a short repertoire and will have an opportunity to perform at the end of the year.

### Injuries

Parents, legal guardians, or any other authorized adult responsible for a child(s) in this program waive the right to any legal action for any injury sustained resulting from normal vocal activity or any other activity conducted by the students before, during, and after lesson time. Parents/guardians will be notified immediately after class of any injury that occurred. No tuition will be reimbursed due to an injury. Safety is key, so the class will be offered in a large open room, and sanitization precautions will be implemented.

### Class Rules

Students will be required to bring their instrument bag and Music Theory Coloring & Activity Book each week. To combat COVID-19, it is required of all students to wash their hands upon arrival. Under no circumstance should your child attend class if feeling ill. If your child did not attend school due to an illness, please do not have them attend class. Please inform Skyler's Music Studio, LLC in advance if the child is unable to attend for any reason.

### Bi-Weekly & Monthly Tuition Payments

Monthly tuition payments are due on the 25<sup>th</sup> of the month, and bi-weekly tuition payments are due on the 25<sup>th</sup> and the 15<sup>th</sup> of the month, via Square. Holidays are already built-in, except for the half months of September and December. Tuition payments are not refundable once that month's classes have begun. If tuition is not paid by the due dates, the student will not be on that month's class roster.

### Drop-Off/Pick-Up

Classes will begin promptly at 4:30pm. Doors will open at 4:20pm for drop-off. If the student will be arriving any time after 4:30pm, please text 540-227-7546 to inform the studio in advance and again when they are at the door. Pick-up will be between 5:30pm and 5:40pm. Parents are responsible for making sure students are dropped off and picked up within the given timeframe. Students are not permitted to wait outside the premises, or in the hallways of the building, as other businesses operate in the facility. No child may leave the premises unaccompanied by an authorized parent/guardian. If the child is to be dropped off or picked up by an individual other than the point of contact that we have on file, please notify us immediately via email in advance. Identification may be asked of the individual to confirm they are the authorized designated person.
